## Residential Parking Permit Zone Petition

Residential Parking Zones (RPZ) were created to address safety and livability concerns in residential neighborhoods caused by non-residential sources. Residents may apply to have an area designated as a RPZ through a community-initiated petition submitted to the City Manager. The petition must be signed by a resident from at least 60% of the addresses proposed for inclusion in the RPZ. A fee may be charged for each issued permit.
